

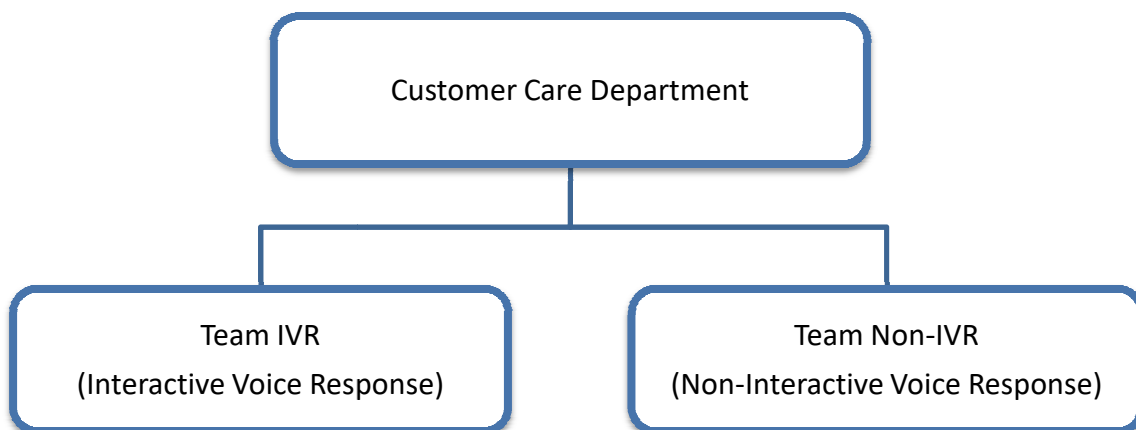

The Customer Care Department is divided into two teams



Despite all the efforts possibility of grievances cannot be ruled out and Moneywise Finvest Ltd endeavors to address all complaints regarding service deficiencies or other grievances.

The Policy seeks to ensure that:

- Grievance, if any, that may arise pursuant to the trading services provided under rules, regulations and guidelines provided by SEBI / Exchanges from time to time be redressed through Investor grievance mechanism of the Company.
- Whenever any E-mail is received on contact@stoxkart.com; or igc@stoxkart.com than an auto generated Ticket number is assigned to client.
- Client can call us or E-mail us for raising his complaint. FTR (First time resolution) is provided on call if possible and if it is time taking than asked the client to write us an E-mail.
- All grievances have proper recording facility where all the incoming grievances are recorded and when and how they are addressed also maintained properly.
- Grievances shall be resolved in a time bound manner with detailed advice to the investor. In case the resolution needs time, an interim response, acknowledging the grievance and its follow-up issued to all the interested parties i.e., Exchanges & clients etc.

1. **Mechanism to redress investor grievances received directly from client, either at head office or Authorized Person office :-** Our Customer Support Team (CST), is the window which opens both way having customers at one way and on counter direction MFL is positioned. We have dedicated email id for receiving complaints namely **igc@stoxkart.com** (for Broking operations) and one toll free number 1800-11-3331 which are prominently/sufficiently displayed and communicated to clients through Website, Welcome kit which we send post opening of trading account. We have also implemented IVR systems on which customer can select the different options like Customer Support (Separately for online and offline clients). All the calls are recorded. For the convenience of clients we have separated contact Numbers for online and offline customer support which is 011-71333666 and 1800113331. This team strives to resolve most of the issues which client

raises directly and if, there are issues which require technical investigation it transpires the issues to Second layer of the Mechanism i.e. IGRT. MFL has equipped this Team with adequate support system so that Investor's primary grievances are resolved immediately.

- 2. Mechanism to redress investor grievances received from Stock Exchanges/SEBI:** Investor Grievances Redressal Team (IGRT) which is lead by CS Suman Kumar (Group Head- Corporate Affairs & Company Secretary). Customer Support team passes all the cases which are of serious nature and couldn't be handled in the benchmark Turn-Around-Time (TAT), to this team. After receiving the grievances this team investigates the matter thoroughly after involving interface with all the concerned departments. This team collects all the relevant information related to grievances of Investors like all the requisite documents like KYC, copies of contract notes, account ledger, SMS confirmation report, voice recordings, online trading information accessing report from the concerned department and conducts the basic studies and enquiries of the said grievances in the light of the documents and further makes the detail investigation from the concerned branch / Authorized Person/location from where the trades have been executed. After the detailed enquiry the IGRT sends its findings either directly to the client or through the exchange if the same has been received through the exchange. The IGRT makes the regular report through Management Information System (MIS) regarding receipt of the grievances and their Redressal regularly and submit it to the Director and Compliance officer.
- 3. Escalation of complaints to senior management in cases the internal benchmarks and timelines are not met.** The IGC (Investor Grievances Committee) is the most senior team to take decisions and all the matters which fail to be redressed within the self-defined benchmark time are escalated to this Committee. Investor Grievance committee will comprise of senior level people and One Whole-time Directors. Currently, the Team shall include Mr. Pranay Aggarwal-Chief Executive Officer & Director, Mr. Junaid Akhtar - Compliance Officer, Ms. Monika - AVP (Customer Support), Mr. Tarun Gupta - Manager in legal department of Group Company & Ms. Sonia Gupta Asst. Manager (Customer Support). This team is mandated to meet as per the requirement and minimum 3

members must be present in meeting. This committee is constituted to properly observe, supervise and give direction for handling of investor Grievances.

4. **Internal benchmarks and timelines set out to resolve investor grievances** :- the direct complaints which are addressed by customer support team has TAT of 3 working days to response the issues it receives and Investor Grievances Redressal team has to report its findings with in maximum period of 7 working days from the date of receipt of Grievances.
5. **Steps taken to reduce the number of grievances:-** We at Moneywise Finvest Ltd give utmost priority to Investor's interest. in that regard we have taken number of steps as explained below:
 - Welcome kit capturing all the vital information mentioned by client in CRF along with User-id and password are sent immediately to clients
 - Delivery of Digital contract notes and account statement to all clients with a note that if they find any discrepancy they may call us within 24 hours of receipt of those documents.
 - Mobile confirmation of trades and ledger balance through SMS facility.
 - All De-mat accounts are connected with SMS facility; any movement in those accounts would be duly informed to de-mat accountholders.
 - Investors can raise query over phone / E-mail. If required, the matter is consulted with other departments / concerned persons.
 - Every query is mapped with its TAT so that query resolves on time if not then it escalates according to the escalation matrix.
 - We analyze the cases and proper surveillance is focused on the regions which may come with large grievances. All the respective officials are engaged periodically along with IG head, Accounts head and Surveillance head.
